

# REGULATIONS GOVERNING THE “Salary deposit – 100 Euros – My-day-to-day Banking Campaign” PROMOTION

## Promotion organised by ING Belgium SA/NV

1. The “Salary deposit - 100 Euros” promotion (hereinafter “the promotion”) is organised by ING Belgium SA/NV (hereinafter “ING”) of Avenue Marnix 24, B-1000 Brussels, Brussels Trade Register, VAT Reg. No. 0403.200.393
2. The promotion runs from 07/11/2016 to 03/01/2017 inclusive.
3. The promotion is open to any individual who is a client of ING Belgium, participates in his or her own name, and banks in Belgium, and is strictly reserved for people who have received the e-mail or letter inviting them to participate in the promotion from ING Belgium.
4. In order to participate in the promotion, the client, as defined in Clause 3 above, must have his or her salary paid into an ING current account in his or her own name from between 07/11/2016 and 03/01/2017 inclusive, for a minimum of one year. New salary deposits will be taken into account at 07/11/2016.

Salary deposit is defined as a payment of income from employment or income replacement benefit for which the payment identification number contains “/A” or “/B”.

Each client as defined in Clause 3 of this Regulation who deposits his or her salary as defined above shall receive a payment of €100, which will be paid into the current account into which the salary is deposited within one month following the payment of the salary.

There is no obligation to purchase any product or service from ING Belgium in order to participate in the promotion.
5. The allocation of these 100 Euros will not under any circumstances be disputed except in the event of intentional or gross negligence on the part of ING.
6. Except in the case of intentional or gross negligence on their part, neither ING nor members of its staff nor third parties called upon in the context of this promotion shall be held liable for any damage incurred due to the organisation of this promotion, including participation in the promotion and the allocation of the 100 Euros. Subject to the same conditions, neither ING nor the above individuals shall be held responsible for any technical problem whatsoever during this promotion affecting them, any participant in the promotion and/or any third party, causing an interruption in the promotion, any delay in participation in the promotion or its organisation, or any deterioration or loss of data of any participant in the promotion. If the promotion has to be cancelled, interrupted or modified due to force majeure or any event beyond its control, ING shall not under any circumstances be liable for damages.
7. All participants shall lose their entitlement to the 100 Euros if it is found that fraudulent practices of any kind have been used. ING reserves the right, if appropriate, to request the return of the gift or to exclude the participants in question from any participation in future promotions and competitions organised by ING. Exclusion shall not be disputed under any circumstances except in the event of intentional or gross negligence on the part of ING.
8. The personal data disclosed to ING in the context of this promotion shall be processed by ING for purposes of marketing banking and insurance services (including for the organisation of this promotion) and centralised customer management. These data shall also be disclosed to the other companies in the ING group carrying on banking, financial, or insurance business within the European Union (list on request) for marketing purposes (with the exception of e-mail advertising) and for centralised customer management. All participants may examine their data and have them corrected. They may object on request, at no charge, to the processing by ING of their data for direct marketing purposes and/or the disclosure of such data to other companies in the ING group carrying on banking, financial or insurance business within the European Union for the same purposes. Participants may obtain additional information by consulting Article 6 (Protection of Privacy) of the ING General Regulations.
9. All participants in the promotion shall be deemed to have examined the content of these Regulations. Participation in the promotion implies that the participant unreservedly accepts these regulations and will accept any decision taken by the organisers in order to guarantee the smooth running of the promotion.
10. The promotion is subject to Belgian law.
